The Foundation's multi-year focus called "It's Time for Central" has raised significant funds to help bring high impact improvements and building upgrades to downtown Central Library.

The new Teen Room will be doubled in size and be a great benefit to the Berkeley High School student population of 3,000 a block away.

The city's homeless, underemployed, and unemployed populations who depend on the downtown library as a stepladder to professional growth will continue to be served, and the new program spaces will allow for greater freedom and opportunities for services.

There are over 500,000 patrons visits to the Central Library annually.

The Foundation also supported adult literacy services and a new early childhood literacy outreach project to serve families in childcare centers in underserved and disadvantaged neighborhoods.

We continue to support efforts to put computers into the hands of homeless youth. We have begun a partnership to pilot an innovative science literacy program with the American Library Services award-winning Cornerstones of Science.
